ACCOUNTABILITY: Director of Resident Care

POSITION PURPOSE: Reporting to the Director of Resident Care, the Registered Nurse / Registered Psychiatric Nurse is responsible and accountable for the delivery of direct nursing care to a client or a group of clients and carries out the responsibility under the provisions of the Registered Nurses Act, the philosophies, objectives, policies and procedures of HavenGroup as a contract facility in Southern Health-Santé-Sud Inc., and in accordance with the CRNM / CRPNM standards of nursing care.

The Registered Nurse / Registered Psychiatric Nurse provides leadership to other nursing team members and coordinates the efforts of other staff to accomplish the formulated plan of care. The incumbent will exercise appropriate judgment in the completion of his / her duties and action to be taken on unusual day-to-day matters. The RN / RPN complies with provincial Personal Care Home Standards within the scope of his / her responsibilities. The position functions in a manner that is consistent with the mission, vision and values, and the policies of HavenGroup.
