ACCOUNTABILITY: Director of Housing

POSITION PURPOSE: Reporting to the Director of Housing, the Dietary Aide is responsible for the completion of assigned tasks in relation to the safe preparation, portioning, serving, and distribution of nutritious meals and beverages to tenants. The incumbent is responsible for serving meals to the tenants following current sanitation safety guidelines. This is in addition to following established standards, departmental/regional policies and procedures and government regulations and legislation. The incumbent will exercise the appropriate level of initiative and independent judgment in determining work priorities, work methods, to be employed to assigned duties and responsibilities and action to be taken on unusual matters.

The Dietary Aide will interact with tenants, visitors, family members, and co-workers on a daily basis. It is important to understand that meals and meal times are a very important and enjoyable part of the tenant's day and it is therefore imperative that this position make every effort to make this a positive time of interaction for those we serve. The position functions in a manner that is consistent with resident Bill of Rights, the Mission, Vision, and Values and Policies and Procedures of HavenGroup.

- Current Food Handler Training Certificate Level 1 or equivalent Food Sanitation course or be willing to acquire a Food Handler Training Certificate in the first month of employment
